# **PRESIDENT'S MESSAGE**

As we approach the Texas 82nd Legislative Session beginning on Tuesday, January 11, 2011, TAID is busy working on issues that will affect the business of interior design in Texas.

Federal Mandates and Standards are coming from everywhere and we will try to keep you abreast of as many as we can learn about. The following new laws and manufacturing specifications will mean changes for the ways in which you provide services and product to your clients.

CHILD SAFETY: After hearing reports from parents whose infants and young children were accidentally strangled by corded window coverings and the Consumer Product Safety Commission, the Window Covering Manufacturers Association published the ANSI/WCMA A100.1-2010 (PS). It is the Provisional American National Standard for Safety of Corded Window Covering Products. Discard the 2009 standard. In addition to hang tags for Roman style shades, roll up shades and adjustable length products, we need to learn the new regulations for cord shroud devices, tension devices for cords and stock blinds (off the shelf readymade blinds, etc.) As we are designing the next pair of draw draperies or sun control window coverings, we need to read and understand the new ANSI Standard for their manufacture. Small independent workrooms must use the new standard as well as the huge factories that create corded products by the 1000's. The lawsuits that I have briefly seen name the large manufactures, the reseller and the installer. NEW GAME. Be Informed. The Standards are being sold for \$36 or \$18 if you are a WCMA member.

**CHILD HEALTH:** To protect children from lead dust exposure, there is no OPT OUT for Target Housing, Daycares and Schools. The EPA Lead-Safe Paint Renovation Certification sign up deadline passed and the persons wishing to obtain this certification needed to sign up for classes before September 30, 2010 to be able to complete training by December 31, 2010. Enforcement will start after that date. www.epa.gov/lead/pubs/traincert.htm. This law applies to residential and commercial.

If you have trouble finding an EPA Certified Painter for projects built before 1978, call the Specification Rep of your favorite paint company and he might be able to connect you with a list of painters whose livelihoods depend on being compliant. Your local paint supplier may not be allowed to recommend any painters for liability reasons. ECONOMIC REPORT - LETTERS FROM TAID MEMBERS AROUND TEXAS: I am still receiving letters (interiors04@yahoo.com) from around our state about how Registered Interior Designers are faring in this economy. The main themes are: 1. Starting in January 2009, work was put on hold and is still holding. 2. Marketing calls result in confirmation that some homebuilders have gone out of business thereby forcing their suppliers to also go out of business or cut staff. 3. RID's have moved to home offices and reduced employees to just themselves and/or one other person. 4. No one sees an end in sight. 5. One letter confirmed that the DIYer's are trying to save money and that the RID is called upon for consultation instead of providing services. That RID says that taxing consultation at this time is not a good idea.

THE GOOD NEWS: LEGISLATIVE DAYS IN AUSTIN, MARCH 1, 2011. YOUR CHANCE TO BE HEARD BY YOUR LEGISLATORS. Plan to join TAID members and Interior Design Students from CIDA schools in Austin on 3/1/11. We will have training on 2/28/2011 and the next day meet in the State Capital Building to break into small groups. Each group will call on legislators, their Legislative Aides or staff member to deliver popcorn and TAID brochures. We will deliver the message of how important the planning done by Registered Interior Designers is to every Texan's Health, Safety and Welfare when they are at work, a restaurant, shopping, a hospital or enumerable places used by the public. Last session we became RID, now we have to educate everyone about RID.

If you want to share your experience about the condition of your business, send me an email. I will print them and we will deliver them directly to the legislator's offices. You may use only your region and initials if you prefer to remain anonymous. If you wish to join us, remember everyone pays their travel expenses, splits the hotel cost by sharing rooms, eats in the Capital lunchroom and most carpool to save gas and airfare. TAID will host a Legislative Reception where we network with many legislators and staff members who research issues and prepare position reports for their legislators. This is also one of the best times for speaking with legislators about our issues. If you cannot come, then email your concerns to me so I can have an accurate report for them.

## **Interior Architecture: Why Words Matter** Use of the term can be risky for individuals and the profession

In light of the ongoing national conversation over use of the terms "interior architect" and "interior architecture," it is important to reiterate the legal issues that pertain to use of these terms, as well as the Society's position on the issue. Further, as the leading voice for the interior design profession, ASID is obligated to inform all members of the possible ramifications of using the term "interior architect" to describe themselves, and the term "interior architecture" to describe their services.

Over the years, ASID has watched with growing concern the use of the term "interior architecture" to describe interior design practice and educational programs. As many members probably know, ASID opposes using the term "interior architecture" for the following reasons:

• In almost every state, an interior designer not licensed as an architect may not call themselves an "interior architect," and may not use the phrase "interior architecture" in connection with their interior design business, as such terms may mislead the public into thinking that the interior designer is licensed to practice architecture, when, in fact, only licensed architects may practice architecture or call themselves architects.

Even those who graduated from a college or design school with a degree in "interior architecture" cannot call themselves an interior architect, unless they have indeed passed their state's required professional examinations to become a registered architect.

Violation of these restrictions constitutes a criminal offense in most jurisdictions. Further, the public policy statutes that govern architectural licensing do not impose a standard of "culpability." In plain English, this means that the "I didn't mean it" defense is not available and criminal liability can be established without having to prove any element of intention to violate the statute.

• Interior design is a separate and distinct profession from architecture and not a subspecialty of that profession. To call interior design "interior architecture" clearly implies that interior design is a specialty within the profession of architecture as opposed to a separate profession with separate educational and professional standards.

It is important that consumers understand the difference between an interior designer and an architect so that they may choose the correct professional for their projects.

• Since its inception, ASID has led efforts to legally recognize the interior design profession. In the legislative arena, the public's confusion about the differences between architecture, interior design and interior decoration is one of the biggest hurdles to protecting the public through legally defining the profession of interior design and setting standards of education, experience and examination for its practice.

Consistent terminology that appropriately defines the profession is a key ingredient in the development of interior design as a legally recognized profession in every state.

## A closer look at the Statement of Jurisdiction rule

Here around the TBAE offices, we consult agency rules and statutes all the time. And since we're so familiar with the intricacies of the laws, we have to remind ourselves from time to time that practicing design professionals like you might not be quite so knowledgeable about them.

With that in mind, I'd like to take this time to highlight one little facet of the law that you might not know as well as you should: the "Statement of Jurisdiction" rule.

Before drilling into the specifics of the law, let's think about its intent. The purpose of the Statement of Jurisdiction, or Rule 5.115 if you're research-inclined, is to provide your clients with notice that in the event that something during the course of your project gives rise to a consumer complaint, your client can call TBAE for help in making it right.

In other words, the law says that you, as a Texas Registered Interior Designer, must inform your client that he or she can call us to allege that you did something wrong.

If this is the first time you've ever thought about the Statement of Jurisdiction rule, you may have just had to go back and re-read the sentence above. At first glance, I admit, it looks like a slap in the face. But after carefully thinking about the Statement rule, its meaning becomes clear: if your client hires you, a Registered Interior Designer, and has a complaint about your work, the client doesn't need to hire a lawyer. The client can simply call us for help.

This is one of those glorious cases where two ends are served: the public interest is protected (which is our reason for being), and this client benefit is one of the things you can use to secure a project. In other words, as an RID, you can offer your client a benefit that a nonregistrant can't. And meanwhile, TBAE can address any public interest issues that may arise. Let's get into the specifics of the rule, shall we?

First, as a Registered Interior Designer, you're required to provide the Statement of Jurisdiction—in writing—to each client. The language is provided for you: "The Texas Board of Architectural Examiners has jurisdiction over complaints regarding the professional practices of persons registered as registered interior designers in Texas." The TBAE mailing address and phone number (provided below) must accompany the statement.

Your next question might be, "How, when, and where do I need to provide the Statement?" There are a few things to consider, and it's simplest to break them down this way:

- If you enter into a written contract with the client, the statement must be included in the contract.
- If you don't use a written contract, you have two options (no requirement to do both):
  - You can include the statement in each bill you send to your client, or
  - If the client visits your office, you can post the statement on a sign prominently displayed in your office.
