# Executive Director News

What gorgeous weather we are enjoying – just wish it would never stop, but then again everyone would move to Texas and we can't have that or can we? Oh, well, as you can see this could go on and on. Hello -

The annual art event in Houston has also been moved to the Fall and that date will be announced shortly, most likely October 12th.

The board recently voted to change our regions from four to five and created the Central region with that change Marilyn Roberts became our first Vice President of the Central region. Please see our new regional map and VP's on page 6. We are thrilled to welcome back to our board outgoing TBAE interior design board member, Lew Vassberg, who will take over Marilyn's position as VP of Legislation. Both Marilyn and Lew were sworn in by our President, Rosa Salazar at our last board meeting in San Antonio. The board also elected Sally Dinsmoor as our VP for the West Region and she will be joining us at our next meeting.

The last legislative session was charged with redistricting and as usual this usually brings a change in the legislature. The 2012 election season is open: The first day of the official filing period for the 2012 elections is still weeks away

and we've already had 26 State Representatives and 4 State Senators formally announce that they won't be seeking re-election next year. And we are not through yet.

Combined with the 38 new House members elected in 2010 and over one-third of the House will have one session or less experience. All four the State Senators were committee chairs, so the loss of leadership, not to mention their collective 64 years of institutional knowledge, will be considerable. (Three of the four also served in the Texas House, so you could theoretically add another 24 years of lost legislative experience, except the House and Senate are so different that it's almost "a different arena" when moving across the Rotunda.

The very large number of very recently elected legislators, the greater the potential that one or more will introduce an ill-advised bill, like a tax on professional services or changing you can do what in the design build area.

Our work is cut out for us, this means we will have to get active in the campaigns of those running for the first time or those with only a session or less experience, those who haven't become set in their way of thinking. If we do, we will have the opportunity to educate them, to show them that we care about issues such as accessibility and sustainability in all environs.

As we look across the United States, there are other changes as far as the interior designers are concerned. Florida was very luck to save themselves from deregulation in the Spring but there is almost certainty that more legislation will be filed to deregulate them again. The Institute for Justice has filed with the US Supreme Court to repeal the federal courts decision and while we don't think the case as merit, one never knows. Mississippi became the latest state to register interior designers bringing the total to 27 with the most populous states included.

# TAID Pac needs your Help!

The Texas Association for Interior Design (TAID) was formed as a result of a group of concerned interior designers getting together to protect the future of the design profession. Over the years, it became apparent that we needed our own Political Action Committee.

It is the responsibility of TAID-PAC to raise its own funds. The PAC CANNOT receive any funds directly from TAID general funds. All PAC money must be from personal checks made to TAID-PAC. These PAC dollars go to contributions to the legislators that are supportive of our political agenda, and they are typically used for election campaigns.

On the state level, these legislators work for around \$7,200 per session. Therefore, they need help to fund their elections. Other similar professions, i.e. the architects, raise close to \$60,000 for their PAC per legislative session. If we are to participate in the political process and protect our profession, we must raise more money for our TAID-PAC.

DESIGNPAC supports legislators and statewide officeholders who have supported or shown an attitude of support to the profession of interior design. It is critical that we not only retain these people in public service but also continually recruit and elect new supporters of the profession. This was created so that we could put it on your credit card and we all know that most of us would just look at \$25.00 on our credit card as another meal but I can't begin to tell you what a difference it would make to TAID - PAC.
